5. That the school shall comply with Clause 14 of order No.F.DE/15(56)/ACT/2009778 dated 11.02.09 in r/o maintenance of DRF. The School also ensure to follow FN-21 "Accounting by Schools" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
6. That the school shall observe the relevant provisions of RTE Act, 2009, DSEAR, 1973 and directions/instructions issued by the Department from time to time.
7. That the school shall comply with the orders/guidelines of DoE and judicial pronouncements w.r.t. utilization/maintenance of school funds.
8. That the school shall comply with the orders dated 07.11.17/guidelines of DoE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.

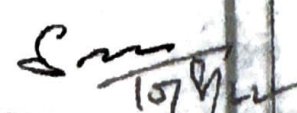
